


### SIZING AND PLACEMENT

INSTALLER NOTE: Due to the variety of different applicable vehicles and cargo bodies, this product does not come with included body fastening hardware, and must be supplied by the installer.

This kit contains a universal upright which may require height modifications. Installers should determine the available maximum installation height and other obstructions such as wheel wells to determine required height modification using the following guidelines. Special consideration should also be made for the orientation of the top mounting plate and it position on the side wall.





### HORIZONTAL WALL MOUNTING PLATE DRILLING LOCATIONS

DRILLING LOCATIONS: Measure the height distance from the Mounting Bracket Hole to the floor of your vehicle as in Fig. 1

Fig 2: 16.00" is the Left/Right Center distance for drilling. To determine overall drilling height, add 2.125" to your height measurement from Fig. 1

\*Regardless of upper or lower hole selection, dimensions in Fig. 2 are identical




