
## **ROTATION ASSEMBLY SEQUENCE**





NOTE: This Rotation Kit fits both Right and Left sides.


This Assembly Manual shows right side assembly procedures on Front & Rear Crossbars. Left side assembly procedures are mirrored and identical to the right side.




Interlocking Crossbar is used in the rear position for all Low Roof models.




